CONDITIONS OF SALE

1. **WARRANTY** – it is warranted that the information furnished on the previous page is true and correct in every aspect. The following shall be the sole terms and conditions upon which ENSIGN IT CC T/A DYNAX shall sell goods on credit to the applicant. ENSIGN IT CC T/A DYNAX shall not be bound by conditions or purchase stipulated by the purchaser unless such have been reduced to writing and signed by duly authorized representative ENSIGN IT CC T/A DYNAX accepting the same.
2. **OWNERSHIP** – Notwithstanding delivery of any equipment, ownership shall not pass to other purchaser until the purchase price of all the goods sold has been paid in full.
3. **CHANGE OF ADDRESS** – The purchaser undertakes to notify the supplier forthwith in writing of any change of address.
4. **PURCHASE PRICE** – The purchase price for every purchase by the purchaser in terms of the agreement shall be payable C.O.D. subject however to the conditions that credit terms shall at all times be at the sole discretion of the supplier and may be altered and abolished at any time without notice to the purchaser.
5. **PAYMENT** – Payment of any particular purchase made hereunder is overdue, the purchase price for all Purchases made hereunder shall immediately become due and payable despite the provisions of the previous paragraph.
6. **INTEREST** – The purchase agree to pay interest at 26% PA on all overdue accounts. A penalty of R 100.00 will be charged on any RD [Refer to Drawer] cheques and no terms will be allowed.
7. **JURISDICTION** – The purchaser hereby consents in terms of section 45 of the magistrates court act to the jurisdiction of the appropriate magistrates court in respect of any legal proceeding arising wherefrom notwithstanding that such proceedings would otherwise have been beyond the jurisdiction of such magistrate’s court. However, notwithstanding such consent, ENSIGN IT CC T/A DYNAX shall be entitled in its sole discretion to institute such proceedings in the appropriate SUPREME COURT.
8. **LEGAL COSTS** – In the event of ENSIGN IT CC T/A DYNAX instructing it’s Attorney to collect any Amount owing from a Purchaser, the Purchase shall pay all costs so incurred ENSIGN IT CC T/A DYNAX on the tariff as between an attorney and his own client including collection commission at the rate of 10% on all payments plus VAT.
9. **NON-WAIVER** – The failure by ENSIGN IT CC T/A DYNAX to strictly enforce any provisions of these conditions shall not be construed as a waiver by ENSIGN IT CC T/A DYNAX of any of its rights in terms hereof nor shall it prejudice ENSIGN IT CC T/A DYNAX right to strictly enforce such conditions.
10. **SURETYSHIP** – In the event of the signatory to this form signing same in his/her capacity as Trustee or Agent for a company and/or close corporation to be formed or as Director, Shareholder, agent of company or member or agent of a close corporation already formed, then such signatory hereby binds himself/herself as surety and co-principal debtor in sodium, jointly and severally for the due performance by such company or close corporation of all it’s obligations to ENSIGN IT CC T/A DYNAX in respect hereby renouncing the benefits of the legal exceptions of excussion and division and further acknowledging that no indulgence, extension of time or release granted by ENSIGN IT CC T/A DYNAX to such company or close corporation shall in any way affect it’s rights to claim from the surety.
